Course Goals

Course Description

This course provides an overview and assessment of the essential features of and contemporary developments in Pentecostal theology, including the diversity of the global Pentecostal movement.

Relationship to Horizon's Mission

As part of Horizon's mission to prepare competent Christian leaders, this course will help students become more aware of the expansiveness of Pentecostal theology and thereby grow in the following competency:

• Biblical and theological literacy: demonstrated by skilled interpretation of scripture and evaluation of theological issues in order to articulate how to think, live, and minister in light of who God is, who God's people are, and God's purposes for the world.

Course Competencies and Learning Outcomes

To demonstrate competency in biblical and theological literacy, students will

- 1. Evaluate perennial issues in Pentecostal theology.
 - Assessment: Perennial Issues in Pentecostal Theology, Pentecostals on Spirit Baptism
- 2. Identify ways in which Pentecostal theology is developing today to influence all areas of theology.
 - Assessment: Developments in Pentecostal Theology
- 3. Analyze the theological diversity of the global Pentecostal movement.
 - Assessment: Pentecostal Theology Globally
- 4. Construct a sustained and in-depth analysis of a topic relevant to Pentecostal theology.
 - Assessment: Research Paper in Pentecostal Theology

Course Assignments and Activities

To begin the course, please *familiarize yourself with the four lessons on Populi*. Review the "Introduction" lesson and watch the "Lectures on Baptism in the Holy Spirit" lesson, which will take about 3 hours. At this point, you only need to be aware of the content of the other two lessons.

1. Perennial Issues in Pentecostal Theology – 15%

In this assignment you will evaluate some perennial issues in Pentecostal theology. For this assignment you will read:

- Palma's *The Holy Spirit* (chapters 11-14 only)
- Menzies' Spirit and Power (chapters 10-13 only)
- The Routledge Handbook of Pentecostal Theology (chapters 28 and 30).

You will then write a 900-word paper (max 1000 words), with appropriate references to all three

books. Begin by critiquing key ideas that stood out to you in the readings—that is, highlight and explain points that you thought were particularly strong and points that you thought were problematic (2 pages)—and then conclude by identifying applications that would be useful for your church (1 page). A bibliography is not required for this assignment.

• Assignment length: 900 words (about 3 pages).

2. Pentecostals on Spirit Baptism – 15%

In this assignment you will evaluate different Pentecostal views regarding baptism in the Holy Spirit. For this assignment you will read

- Menzies' Spirit and Power (chapters 7-9 and 14)
- Macchia, *Baptized in the Spirit* pages 11-88, 98-107, and 166-168 (total=81pages). Menzies holds to a typical classical Pentecostal view of Spirit baptism, whereas Frank Macchia is among those Pentecostal scholars who are redefining what they mean by Spirit baptism, although often still integrating a classical Pentecostal view of Spirit baptism. For this assignment you will evaluate Menzies and Macchia's view of Spirit baptism by summarizing and comparing and contrasting their views, but also by giving your own assessment of their views. You may include comments about how their views compare to what you have heard about Spirit baptism in your own experience of Pentecostalism. You may present your assignment as a paper (about 900 words, max 1000) or as a live oral report and discussion (via a video messenger, if necessary). If you choose the latter option, before your report you will submit point-form research notes (indicate your sources) that are structured according to the outline of your report. A bibliography is not required for this assignment.
 - Related learning outcome: 1.
 - **Assignment length:** 900 words (about 3 pages) or an oral report and discussion with research notes.
 - **Due date:** Feb 6, 2026.

3. Developments in Pentecostal Theology – 25%

The *purpose* of this assignment is to expand your awareness of issues in Pentecostal theology. You will read the following from *The Routledge Handbook of Pentecostal Theology*:

- Part 1: Choose any 1 chapter.
- Part 2: Choose any 1 chapter.
- Part 3: Read chapters 14 and 16.
- Part 4: Read chapter 18. Also choose 6 other chapters in part 4 to read.
- Part 5: Read chapter 38. Also choose 6 other chapters in part 5 to read.

You will write a 1200-word report on how this assignment has expanded your awareness of issues in Pentecostal theology, including ways that Pentecostal theology is developing today to

influence all areas of theology. Your report should include evaluative comments regarding the observations you are making and comments regarding how some of the things you are learning could be relevant for your church or Christian living in general. Include footnotes and specific interaction with the material you read to offer examples and illustrations of the general observations that you make regarding Pentecostal theology. Include a bibliography with this assignment that lists all the chapters that you read. See p. 16 in the *Horizon & MCS Format Guide* regarding how to cite "Part of a book: a chapter from a collection of essays" in both footnotes and the bibliography.

• Assignment length: 1200 words (about 4 pages).

4. Pentecostal Theology Globally – 10%

Read chapters 9-14 in Anderson's *An Introduction to Pentecostalism* (2nd edition). Write a two-page essay (about 600 words, max 700) and analyze the theological diversity of the global Pentecostal movement by explaining 1) how Pentecostal theology globally compares to your own awareness of and experiences of Pentecostal theology (noting both similarities and differences from your experiences) *and* 2) key points in this reading that have expanded your understanding of Pentecostal theology. Although Anderson sometimes focuses on North American Pentecostal theology in these chapters, you should concentrate on discussing aspects of Pentecostal theology around the globe (rather than on how Pentecostal theology has been expressed in North America). As you read, you will notice that, along with theology, Anderson discusses Pentecostal history and practice. Please note, however, that your paper should focus specifically on the *theology* of Pentecostals globally. A bibliography is not required for this assignment.

• Related learning outcome: 3.

• **Assignment length:** 600 words (about 2 pages).

• **Due date:** Mar 13, 2026.

5. Research Paper in Pentecostal Theology – 35%

You may write on any topic that relates to the content that has been covered in this course. Research papers should include a thesis statement that you aim to support by means of the arguments in your paper. Given that this is a paper in Pentecostal theology, you should engage primarily with Pentecostal authors. As you write your paper:

• Aim for **4000 words** (about 13 pages), not including your **footnotes and bibliography** (include both of these with your paper).

• Aim to use at least 12 <u>scholarly</u>² <u>sources</u> (dictionary definitions do not count as sources). Your sources should include at least two journal³ articles, two books, and one <u>web page</u>. You are welcome to use your textbooks as sources.

Although you are most welcome to choose other topics, here are some possible options:

- a) Pentecostalism and some aspect of Systematic Theology (e.g., Ecclesiology, Theology of Religions)
- b) Pentecostal Eschatology
- c) Healing in Pentecostal Theology
- d) Suffering and/or Prosperity in Pentecostal Theology
- e) An Assessment of the Oneness Pentecostal View of God
- f) Sanctification in Pentecostalism
- g) The Baptism of the Holy Spirit and Subsequence
- h) The Doctrine of Initial Evidence
- Related learning outcome: 4.
- Assignment length: 4000 words (about 13 pages).
- **Due date:** April 14, 2025.

Academic Integrity

Students learn best when practicing academic integrity. A lack of integrity is displayed in acts such as deception, abuse of confidentiality, cheating, inappropriate collaboration, or plagiarism. Plagiarism occurs when a student presents the words or ideas of another person or an artificial intelligence (AI) tool in such a way as to give others the impression that it is their own words or ideas. In academic writing, there should be no doubt which words or ideas are the student's and which are drawn from other sources or AI. Students are expected to submit their own original work and give due recognition to sources from which all substantial phrases, sentences or even ideas are drawn. Note also that you may not submit work done in one course to satisfy the requirements of another course (unless both instructors agree beforehand to accept such work). Horizon has a subscription to software that ensures the originality of academic writing, verifies the proper citation of all sources, and detects AI-generated content. When you submit an assignment, you will automatically receive a summary on Populi that includes your submitted files along with an originality score (a high originality score is positive).

Artificial Intelligence (AI) Usage

In keeping with the Academic Integrity policy above, students must disclose on the title page of all assignments whether or not they have used AI and how they have used it. If the assignment has no title page, the student must disclose this to the instructor by some other means, such as in a comment on Populi.
